INTRODUCTION

This report presents the Norm-Based Engagement activities that were carried out by ISS ESG on behalf of participating institutional investors during 2024.

The first section of the report provides an overview of the ISS ESG Norm-Based Engagement approach. This is followed by sections presenting overall engagement statistics for 2024, key engagement topics, as well as engagement outcomes including selected engagement spotlights. The report also includes an appendix covering details of dialogues held, unresponsive companies, engagements that were closed in 2024, as well as companies unresponsive to long-standing controversies.

ISS ESG NORM-BASED ENGAGEMENT APPROACH

ISS ESG's Norm-Based Engagement facilitates engagement with issuers on behalf of participating investors who would like to encourage corporate disclosure of efforts taken to manage or mitigate the environmental and social risks connected to business activities or operations. By engaging collaboratively, participating asset owners and managers can wield more influence than through solo engagements, while saving time and resources.

Engagement Scope

Through ISS ESG's Norm-Based Engagement, participating investors can focus on companies that are assessed under ISS ESG Norm-Based Research to be involved in alleged or verified severe, systematic, or systemic failures to respect international norms. The engagements are categorised under the four United Nations Global Compact areas of human rights, labour rights, environment, and anti-corruption. Each engagement is identified by one or several specific topics within these areas, e.g., union rights, workplace discrimination, health and safety, child labour and forced labour within the labour rights norm area. Participating investors have the option to opt in or out of each individual company engagement.

Engagement Process

The engagement is preceded by in-depth research and fact-finding dialogues with companies and stakeholders through ISS ESG Norm-Based Research. Once a company is identified to be involved in a relevant controversy it is considered for Norm-Based Engagement, which is conducted on a rolling quarterly basis. Through these feasibility studies, ISS ESG identifies gaps in company disclosure and assesses whether investor dialogue is an appropriate means to reach the goals set by the participating investors. Influential factors include an estimation of the company's level of responsibility, mitigating steps it has taken to mitigate the possible failure to respect a norm, and availability of both stakeholder and expert sources to facilitate constructive dialogue. The engagement dialogue is initiated through letters to companies, sent by ISS ESG on behalf of participating investors. Dialogue may be conducted in writing or through calls and meetings, facilitated by ISS ESG. Some companies require repeated follow-ups to respond. Should the company remain unresponsive, enquiries are escalated to the CEO and the Board. Once efforts have been made to engage both Investor Relations and a company's Executive Management, the feasibility of engagement is re-evaluated.

Engagement Outcomes

At the outset of each engagement, clear and actionable goals are defined within four key categories: disclosure, implementation, remediation and termination. Information provided by the company through the course of the engagement dialogue is assessed against the goals. ISS ESG also assesses the company's quality of participation in the engagement. Where the goals have been fulfilled and the controversy – or the risk thereof – is assessed to have been resolved, the engagement is closed. If there is insufficient information to determine whether the goals have been fulfilled, the engagement may be suspended pending developments in the controversy or the disclosure of further information by the company and may subsequently be extended. Alternatively, where there is a poor outlook for the achievement of goals for the engagement, the dialogue may be discontinued.

ENGAGEMENT STATISTICS

During 2024, ISS ESG conducted Norm-Based Engagement on behalf of participating investors with 124 companies, covering 189 individual ESG topics. The companies engaged with are domiciled across 28 different locations. For 100 of the companies, a new engagement cycle was initiated during 2024. Some 71% of the 100 companies provided responses to the investor outreach. The total number of substantial interactions in 2024 amounted to 529.

Charts 1-4: Summary charts of engagements conducted between 1 January 2024 and 31 December 2024






Quality of Participation²



ENGAGEMENT TOPICS

In 2024, in the area of human rights, the key engagement topics were indigenous rights and standards of living, followed by consumers' right to privacy. Forced labour was the dominant labour rights topic, followed by safe and healthy working conditions and just and favourable conditions of work. Most environment-focused engagement topics were related to corporate management of environmental impacts, pollution (air, water, and soil), and climate change. Within the area of anti-corruption, key engagement topics were anti-competitive behaviour and accounting /disclosure standards.

ENGAGEMENT OUTCOMES

One of the key outcomes of Norm-Based Engagement activity during 2024 is that participating investors elicited greater transparency from companies, marking a new record response rate of 71%. In most cases, improvements in disclosure and openness to dialogue were achieved gradually after persistent reminders and follow-up. Engagement success was achieved with companies which increased transparency, stopped a controversial practice, or announced a concrete and time-bound strategy for risk mitigation.

Selected Engagement Spotlights

The selected engagement spotlights below illustrate both successes and remaining work to be done in some of the major 2024 engagement topics, including environmental impact, indigenous rights, pollution, safe and healthy working conditions and standard of living.

In Q2 2024, ISS ESG shared a letter with **Hochtief AG** on behalf of participating investors regarding the company's controversies related to environmental impact and indigenous rights in Canada.

In an engagement meeting facilitated by ISS ESG in September 2024, the company elaborated on its role in the Site C dam project as a contractor and highlighted that the environmental impact assessment (EIA) is the project owner's responsibility as part of the legal approval processes. The company further emphasised that projects like Site C are approved only after careful consideration of economic, environmental, and social benefits and that contractors only get involved after the governmental approval process is completed.

ACTIVITY SUMMARY Regarding environmental risks, the company noted that its involvement followed thorough assessments, including reviewing the government-approved EIA. The company's subsidiary Flatiron Constructors Canada Ltd. and its partners participate in mitigation efforts, such as an environmental review process and a water quality monitoring program, in the Peace River delta and Wood Buffalo National Park. The company stressed that Site C is part of Canada's clean energy transition by replacing fossil fuels with hydroelectric power.

On social impacts, Hochtief highlighted that indigenous rights are addressed through a similar assessment process. It pointed out that in 2023, five indigenous communities settled with the government, and no further claims have been made. Hochtief emphasized that claims related to social or human rights issues should be directed to the government or the project operator, BC Hydro. Hochtief also highlighted its efforts to engage indigenous communities, including awarding over USD 150 million in contracts to indigenous contractors and providing 200,000 hours of apprenticeship training, both exceeding contractual targets. The company

confirmed that its due diligence processes, including environmental and social aspects, are thoroughly embedded in its operations, although its ability to influence project design is limited once the tendering process begins.

Based on the information Hochtief provided in this engagement dialogue, the company was assessed to have made positive progress on all engagement goals of the environmental impact and indigenous rights topics in Canada. The company was assessed to have demonstrated an excellent quality of participation for both topics. ISS ESG continues to monitor the efficacy of the company's remediation measures.

In Q2 2024, ISS ESG shared a letter with **TC Energy Corporation** on behalf of participating investors regarding the company's indigenous rights controversy in Canada.

In an engagement meeting facilitated by ISS ESG in September 2024, the company outlined its engagement with affected indigenous communities, especially the Wet'suwet'en First Nation, during the approval and construction of the Coastal GasLink (CGL) pipeline project. The project was approved by the British Columbia government in 2014, and the company took on the duty to consult with indigenous communities, as delegated by the Canadian government. The process was challenging due to internal divisions within the Wet'suwet'en, particularly between hereditary and elected leaders. While elected leaders supported the project, a group called "Dark House" opposed it, leading to unresolved tensions. Despite efforts, including environmental assessments, consultations, and monitoring programs, TC Energy could not reach an agreement with Dark House, which continued to oppose the project during construction, although over time, the group became more open to engagement.

ACTIVITY SUMMARY

TC Energy stated that it implemented various grievance mechanisms, including an ethics hotline, relationship leads, and thousands of community meetings. The company expressed confidence in the project's environmental and social approval process, stating that it has no plans for an independent third-party human rights impact assessment. TC Energy further stated that it does not expect the hereditary chiefs' opposition to change as the company believes the opposition is against industrial development more broadly. The company stated its respect to the group's right to protest and continues efforts to engage, though internal governance issues within the community remain a challenge.

Based on the information TC Energy provided in this engagement dialogue, the company was assessed to have made positive progress on all engagement goals of the indigenous rights topic in Canada. Furthermore, the company was also assessed

to have demonstrated an excellent quality of participation. ISS ESG continues to monitor the efficacy of the company's remediation measures.

In Q4 2024, ISS ESG shared a letter with **Vale SA** on behalf of participating investors regarding the company's water pollution controversy at the Fundão dam and safe and healthy working conditions and standard of living at the Córrego do Feijão mine in Brazil. In a written response to ISS ESG's investor enquiry in December 2024, the company addressed all three topics.

Concerning water pollution in Brazil, the company was assessed to an excellent quality of participation. The company stated that the Doce River water can be consumed after undergoing conventional treatment by the municipal supply systems and that monitoring of surface water quality and water supply quality is carried out by national laboratories certified by Brazilian standards. Vale also shared it is appealing the ongoing fishing ban and compensates fishermen. Furthermore, Vale highlighted that the Definitive Settlement Agreement was signed in October 2024, which provides for a total financial value of approximately R\$ 170 billion.

ACTIVITY SUMMARY Concerning safe and healthy working Brazil, the company was assessed to a good quality of participation. The company shared that its labour agreements were not made within the scope of the Integral Reparation Settlement, but the company entered into several compensation agreements with workers' unions. Vale has committed to remove all tailings storage structures at the highest emergency level by 2025 and has currently one dam remaining at that level. Vale also highlighted that it is in compliance with the Global Industry Standard on Tailings Management and has intensified its preventive, corrective, and monitoring actions on its structures including the creation of a Geotechnical Risk Committee. The company also shared that it has independent third-party audits of the ongoing reparation settlement.

Concerning standard of living in Brazil, the company was assessed to an adequate quality of participation. The company referred to its public disclosures for details on remediation and shared information about its grievance mechanisms.

Based on the information Vale provided in this engagement dialogue, the company was assessed to have made positive progress on all engagement goals of the safe and healthy working conditions and standard of living topics, while the goal statuses for the water pollution topic remained unchanged. ISS ESG continues to monitor the efficacy of the company's initiated measures to remedy the controversies.

Companies Unresponsive to Long-Standing Controversies

The following companies continue to be involved in long-standing controversies and progress is yet to be seen in Norm-Based Engagement. While ISS ESG will continue to monitor the feasibility of engagement, investor clients may consider these companies and engagement topics for further due diligence.

The identification has been made by ISS ESG based on companies which have — in the last five years and in more than one engagement cycle — been either unresponsive or where responses have been assessed as poor, as the company did not address the ESG topic(s), the engagement questions posed or provide information on the management of the issue. The identification also considered where the status for the engagement goals set for Norm-Based Engagement remain at "no measures announced". A further factor of consideration is the status of the controversies as well as fact-finding dialogue with the company conducted under Norm-Based Research. The subsequent tables listed under the "Companies Unresponsive to Long-standing Controversies" section of the Appendix provide further details, including the quarter of initial outreach, themes and location.

For additional due diligence, investor clients may also want to consider companies with which engagement on specific topics has been discontinued, but where the controversy remains ongoing.³
